Variable speed control range: 0-3000 rpm during mixing.

Vibration dampening foam (or equivalent) to prevent movement during operation should be supplied.

Position Sliders: 3 Nos. for touch/stand by/continuous operating modes.

Standard center pad area for hand held mixing attachment needs to be supplied
